### Parent Responsibility and Permission

I accept responsibility for all items that are checked out and will return them in the same condition as they were received. I will follow the charging instructions for the Chromebook, which includes: **Only charge the Chromebook for a 4 hour period.** Do not leave the Chromebook charging unattended or overnight. I and my student, including our heirs and assigns, agree to release, forever discharge, indemnify, defend, and hold CSD harmless from any and all claims arising from my or my Student's use, misuse, or possession of the Chromebooks and/ or mobile hotspot issued to the Student pursuant to this Agreement including but not limited to any and all damages whatsoever kind or nature. I will ensure the safe and timely return of the equipment within the loan period. I also understand that I am financially responsible for the loss or willful, malicious or accidental damage or loss of the equipment. The value of the technology is \$275.00 (Chromebook \$175.00, hotspot \$100.00). I also understand that loss or damage of equipment may result in loss of future checkout privileges.
